#### **ADMINISTRATOR'S REPORT**

#### **New Primary Election Date**

The Court of Appeals of Maryland issued an Order, In the Matter of 2022 Legislative Districting of the State, moving the 2022 Primary Election from June 28 to July 19. The Order also amends certain deadlines for the Primary Election Calendar.

# The following deadlines have been amended:

1. The deadline for filing certificates of candidacy, established pursuant to Election Law Article ("EL") § 5-303, is extended to Friday, April 15, 2022 at 9:00 p.m.;

- 2. The deadline for candidates to withdraw a certificate of candidacy, established pursuant to EL § 5-502(a), is extended to Monday, April 18, 2022:
- The deadline to fill a vacancy in candidacy for a primary election, established pursuant to EL § 5-901, is extended to Wednesday, April 20, 2022;
- 4. The deadline to challenge a candidate's residency, established pursuant to EL § 5-305, is extended to Thursday, April 21, 2022.

HB35/SB158 - The enrolled bill states that in both the 2022 statewide primary and general election, in-person voting on election day shall be conducted at a total number of precinct polling places that is at least equal to the total number of precinct polling places that were open for in-person voting on election day in the 2018 statewide general election. The total number of precinct polling places required to be open for voting in the 2022 statewide primary election and the 2022 statewide general election may not be reduced: by a local board of elections or the State Board of Elections under § 2-303 of the Election Law Article; by a circuit court or any other court under §8-103(b) of the Election Law Article; or except as provided in subsection (d) of this section, by a person acting under authority of any other provision of law. This section does not limit the authority of the Governor to specify alternate voting locations under §8-103(a) of the Election Law Article during a declared state of emergency.

With the passage of this bill, the polling place plan that was passed during the March 2<sup>nd</sup> board meeting will need to be rescinded as we will no longer meet the requirements of the new law. The polling place plan approved earlier this month included 25 polling places compared to 36 polling places in 2018. Mrs. Loibel explained that part of the reason for consolidating was because of the severe election judge shortage following the COVID-19 pandemic and that several locations were no longer willing to serve as polling places. We are working on a recruitment plan, but finding democratic election judges is proving to be a real challenge as well as finding new polling locations that are ADA compliant.

Mrs. Spiker made a motion to rescind the motions from the March 2<sup>nd</sup> board meeting where they approved the consolidated polling place plan along with several polling place changes. The Board directed Mrs. Loibel to restore the number of polling places that were in place for the 2018 statewide general election. Ms. Johnson seconded the motion. The motion passed unanimously.

Mrs. Spiker made a motion to approve the following polling place changes. Ms. Johnson seconded the motion. The motion passed unanimously.
